### II. Ag Water Board/Water Supply

- a. PUD Pipeline
  - Irrigation engineer exploration the PUD recommended RH2 and Murray, Smith from their past experiences. Reichhardt and Ebe is also an option. Landon will connect with these and possibly another firm that is doing some drainage work in Skagit. He will bring more information to the next WID meeting. There was consensus it was time to spend some resources to develop the idea.
  - PUD delivery system the board toured the facility to get a better sense of its capacity and issues that need to be considered in order to provide a clear price for an acre foot of water.
- b. AWB Board changes Henry provided an update on changes to the AWB Board. Scott is leaving the board and the presidency. Bertrand WID appointed Greg Ebe to replace him. North Lynden appointed Brad Rader as their representative.
- c. Olympia update Henry provided a brief summary of the closing days of the Legislature. It appears the language from the House which combines funding for both pre-adjudication work and a collaborative process will be the final. This language also requires attention to both fish habitat and farmland preservation.

# III. Drainage/Habitat/Flood

- a. Cougar Creek HPA use Ed gathered all the signatures with Frank's assistance.
- b. Scott Ditch workplan both spring spot cleaning and fall maintenance are needed.
- c. Road ditch cleaning needs:
  - East ditch along Hannegan Road from Scott Ditch to Polinder Rd.
  - East ditch along Lankhaar Rd.
  - Bylsma Road ditches gravel from road blocking water
